



The 3<sup>rd</sup> edition of the International Conference on Applied Management Advances in the 21st Century was held virtually from 14 to 16 December 2022.

This conference was organized by the International Association for Development of the Information Society. The International Conference on Applied Management Advances in the 21st Century (AMA21) seeks to provide a unique forum for presentation and discussion of the latest research developments and solutions for the current issues of the world economy. A global invitation was made to scholars, students, practitioners, organizations, government departments, policymakers and everyone interested in these subjects, to give their contribution.

It was published jointly with the International Conferences on: Educational Technologies 2022 (ICEduTech 2022), Sustainability, Technology and Education 2022 (STE 2022) and Internet Technologies & Society 2022 (ITS 2022). These events received 114 submissions from more than 22 countries. Each submission was reviewed in a double-blind review process by an average of four independent reviewers to ensure quality and maintain high standards. Out of the papers submitted, 17 got blind referee ratings that published them as Full and Regular papers, which means that the acceptance rate was 15%. Some other submissions were published as Short and Concise papers, Reflection papers, and Posters/Demonstrations.
